



# Maritime Security Drills and Exercises Masterclass

# Introduction

Since the adoption of the International Ship and Port Facility Security (ISPS) Code in July 2004, International Maritime Organization (IMO) and Asia-Pacific Economic Cooperation (APEC) Maritime Security Secretariat have identified the Planning and Conduct of Maritime Security Drills and Exercises (DE Manual) as a major challenge in the effective compliance for the implementation of ISPS Code standard. Consequently, the APEC DE Manual has been developed to assist government officials, port facilities, companies and ship owners/operators to use the pre-planned exercises, drills and the multi-media templates provided in the APEC DE Manual, to execute maritime security drills and exercises. The DE Manual (2012 Edition) is considered as industrial best practice by IMO, Organization of American States (OAS) and the US Coast Guard.

Maritime Security Drills and Exercises Masterclass includes practical planning and application sessions to reinforce theory learnt.
